**Montreal, June 10, 2019 -** Hosted by Montreal-based organization Equitas, the International Human Rights Training Program (IHRTP) is a world-leading program on human rights education. Held annually, this program is celebrating its 40<sup>th</sup> year of empowerment in human rights training. More than 100 human rights leaders from forty-five (45) different countries are in Montreal to learn new skills and become more effective in their work fighting human rights violations and promoting fundamental freedoms. The program is a unique learning experience that contributes to Canadian leadership in building respect for human rights around the world.

Henri Tiphagne, Executive Director of People's Watch in India and criminal and human rights lawyer, will provide an overview of the principal issues surrounding the notion of universality from the perspective of a human rights educator. He will also explore strategies for dealing with the real contradictions that exist between human rights standards and a specific culture in a learning setting.

Jean Baptiste is the Governance and Rights Senior Program Officer of Never Again Rwanda. He works to encourage political participation and community development in the country, and engages the media, civil society organizations, and local authorities as key players in the democratic process in Rwanda. Most of his projects focus on the empowerment of the youth in politics, especially in their ability to participate in decision-making and to further human rights causes in Rwanda. His organization also organizes peace-building programs that promote non-violence, genocide prevention education, and

provides help for the victims and children of the 1994 genocide, which occurred 25 years ago.



**Lafir Sahira** – Muslim Women's Development Trust, Sri Lanka

**Lafir** is a project coordinator for the Muslim Women's Development Trust. She provides legal assistance for women impacted by the Muslim Marriage and Divorce Act and victims of gender-based and domestic violence. She is also a national-level advocate for human rights who especially condemns discrimination against women and female genital mutilation.
